ORDER

Government, as per the G O read as 1st paper above, had appointed Sri. K.B Subhash, advised by the KPSC for appointment as Assistant Conservator of Forests under Special Recruitment for SC/ST; and deputed for two years Diploma Course in Forestry 2015-2017 of State Forest Officers at the Central Academy for State Forest Service, Coimbatore scheduled from 05.05.2015. As per Para 11 (d) of the Notification read as 1st paper above, the candidates advised for the post of Assistant Conservator of Forests under direct recruitment, after successful completion of the two years Diploma course, shall report before Government for posting as Probationary Assistant Conservator, and also stipulates that a directly recruited probationary Assistant Conservator of Forest will be given practical training for a period of two years from the date of his appointment as probationary Assistant Conservator of Forests.

2. After the successful completion of his two year diploma

course, Sri. Subhash K.B has been relieved ,as per Order read as 4th paper above, and he has reported for posting before Government. Additional Principal Chief Conservator of Forest (Admn), as per the letter read as 2nd paper above, has also submitted the practical training schedule for the above officer and requested for the approval of the same.

3. Government have examined the matter in detail and are pleased to admit Sri. Subhash K.B, Kodithottathil House, Punchavayal PO, 504 Colony, Mundakkayam, Kottayam, in to duty with effect from the FN of 08.05.2017 and is appointed as Probationary Assistant Conservator of Forest, and deputed for two years practical training as per the conditions stipulated in Notification read as 1st paper above. During the period of training the officer shall be paid the pay and allowances attached to the post of Assistant Conservator of Forest, and this period will count for all service benefits such as pension, increment, leave etc. The practical training schedule submitted by the Additional Principal Chief Conservator of Forest (Admn) is also approved.
