ORDER

G. O. (P) No. 135/2011/Co-op. Dated, Thiruvananthapuram, 21st September, 2011.

S. R. O. No. 615/2011.—WHEREAS, under sub-section (1) of section 33 of the Kerala Co-operative Societies Act, 1969 (21 of 1969), the term of an administrator or administrative committee appointed to manage the affairs of a society shall not exceed one year in the aggregate;

AND WHEREAS, the said term of one year of the administrator appointed to manage the affairs of the Kuttanad Marketing Co-operative Society Limited No. A 194 under sub-section (1) of section 33 of the said Act expired on 2nd August, 2007;

AND WHEREAS, under sub-section (1A) of section 33 of the said Act, the Government may, by notification in the Gazette, for reasons to be recorded, permit the Registrar of Co-operative Societies to extend the term of the said administrator or administrative committee for a further period not exceeding one year in the aggregate or till a newly elected committee enters upon office, whichever is earlier;

AND WHEREAS, the Government have permitted the Registrar of Co-operative Societies to extend the term of the administrator of the said society as per notification issued under G. O. (P) No. 45/2008/Co-op. dated 12th February, 2008 published as S. R. O. No. 233/2008 in the Kerala Gazette Extraordinary No. 415 dated 28th February, 2008 and G.O. (P) No. 7/2009/Co-op. dated 3rd January, 2009 published as S. R. O. No. 36/2009 in the Kerala Gazette Extraordinary No. 135 dated 16th January, 2009 and as per G. O. (P) No. 157/10/Co-op. dated 17th September, 2010 published as S.R.O. No. 926/2010 in the Kerala Gazette Extraordinary No. 2218 dated 27th September, 2010 for a period of one year each from 3rd August, 2007, 3rd August, 2008 and 3rd August, 2009 respectively and the term so extended also expired on 2nd August, 2008, 2nd August, 2009 and 2nd August, 2010 respectively;

AND WHEREAS, the Registrar of Co-operative Societies has reported that the election to the Board of Directors of the said society could not be conducted within the extended period due to the scarcity of funds and the absence of staff in the said society and has requested to permit him to extend the term of the administrator for a further period of two years from 3rd August, 2010 to 2nd August, 2012 for avoiding administrative vacuum;

AND WHEREAS, the Government are satisfied that it is necessary, in public interest, to direct that the provisions of sub-section (1A) of section 33 of the said Act shall apply to the said society with certain modifications and to permit the Registrar of Co-operative Societies to extend the term of the administrator appointed to manage the affairs of the said society for a further period of two years from 3rd August, 2010 to 2nd August, 2012 or till a newly elected committee enters upon office, whichever is earlier to avoid administrative vacuum in the said society;

NOW, THEREFORE, in exercise of the powers conferred by section 101 of the Kerala Co-operative Societies Act, 1969 (21 of 1969), the Government of Kerala hereby direct that the provisions of sub-section (1A) of section 33 of the said Act shall apply to the Kuttanad Marketing Co-operative Society Limited No. A. 194 with the modifications of substituting the words "five years" for the words "one year" and in exercise of the powers under sub-section (1A) of section 33 of the said Act, as so modified, permit the Registrar of Co-operative Societies to extend the term of the administrator appointed under section 33 of the said Act to manage the affairs of the said society for a further period of two years from 3rd August, 2010 to 2nd August, 2012 or till a newly elected committee enters upon office, whichever is earlier.

### Explanatory Note

(This does not form part of the order, but is intended to indicate its general purport.)

The term of the administrator appointed under sub-section (1) of section 33 of the Kerala Co-operative Societies Act, 1969 (21 of 1969), to manage the affairs of the Kuttanad Marketing Co-operative Society Limited No. A. 194 expired on 2nd August, 2007 and extended further in pursuance of notifications issued under G. O. (P) No. 45/2008/Co-op. dated 12th February, 2008 published as S. R. O. No. 233/2008 in the Kerala Gazette Extraordinary No. 415 dated 28th February, 2008 and G. O. (P) No. 7/2009/Co-op. dated 3rd January, 2009 published as S. R. O. No. 36/2009 in the Kerala Gazette Extraordinary No. 135 dated 3rd January, 2009 and G. O. (P) No.157/10/Co-op. dated 17th September, 2010 published as S. R. O. No. 926/2010 in the Kerala Gazette Extraordinary No. 2218 dated 27th September, 2010 expired on 2nd August, 2007. The Registrar of Co-operative Societies has reported that the administrator could not conduct election within the extended period due to the scarcity of funds and the absence of staff in the said society and has requested to extend the term of the administrator of the said society for a further period of two years from 3rd August, 2010 to 2nd August, 2012. The Government have considered the matter in detail and are satisfied that it is necessary, in the public interest, to direct that the provisions of sub-section (1A) of section 33 of the said act shall apply to the said society with certain modifications and to permit the Registrar of Co-operative Societies to extend the term of the administrator of the said society for a further period of two years from 3rd August, 2010 to 2nd August, 2012 or till a newly elected committee enters upon office, whichever is earlier to avoid administrative vacuum in the said society.

The order is intended to achieve the above object.
