NOTIFICATION

G. O. (Ms.) No. 42/2013/PD. Dated, Thiruvananthapuram, 13th September, 2013.

S. R. O. No. 782/2013.—In exercise of the powers conferred by sub-sections (1), (2), (5), (6) and (7) of section 131 and section 133 of the Electricity Act, 2003 (Central Act 36 of 2003) read with clause 12 of the Kerala Electricity First Transfer Scheme, 2008, the Government of Kerala hereby make the following Scheme further to amend the Kerala Electricity First Transfer Scheme, 2008 issued under G. O. (Ms.) No. 37/2008/PD dated 25th September, 2008 and published as S. R. O. No. 990/2008 in the Kerala Gazette Extraordinary No. 2090 dated 25th September, 2008, namely:—

SCHEME

1. *Short title and commencement.*—(1) This Scheme may be called the Kerala Electricity First Transfer (Fourth Amendment) Scheme, 2013.

(2) It shall be deemed to have come into force on the 31st day of August, 2013.

2. *Amendment of Scheme.*—In the Kerala Electricity First Transfer Scheme, 2008, in sub-clause (1) of clause 6, for the figures and word “31st August, 2013”, the figures and word “30th November, 2013” shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per the Kerala Electricity First Transfer Scheme issued under G. O. (Ms.) No. 37/2008/PD dated 25th September, 2008 and published as S. R. O. No. 990/2008 in the Kerala Gazette Extraordinary No. 2090 dated 25th September, 2008 the Government of Kerala took over all the functions, properties, and all interests, rights in properties, all rights and liabilities of the Kerala State Electricity Board. As per sub-clause (1) of Clause 6 of the said Scheme the functions and undertakings of the Board set out in the Schedule thereto and as vested in Government under clause 4 shall stand re-vested in the company on and from the date of the transfer to be notified by the State Government for the purpose of re-vesting, subject to the provisions of the Act and the Scheme, within 30th September, 2009. However, as the procedures for re-vesting could not be completed within the stipulated period, the Government have issued notifications extending the time limit. Lastly as per Notification G. O. (Ms.) No. 34/2013/PD dated 15th July, 2013 and published as S. R. O. No. 567/2013 in the Kerala Gazette Extraordinary No. 2135 dated 22nd July, 2013, the Government have issued the Kerala Electricity First Transfer (Third Amendment) Scheme, 2013 extending the time limit further up to 31st August, 2013. The Procedures for re-vesting are yet to be completed. Hence the Government as per G. O. (Ms.) No. 39/2013/PD dated 29th August, 2013, have issued order extending the time limit up to 30th November, 2013 for re-vesting the assets and liabilities of erstwhile Kerala State Electricity Board to the new company constituted and have also decided to amend the Scheme for the purpose.

The notification is intended to achieve the above object.
