Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Hon'ble High Court of Kerala in its judgment dated 10th February, 2021 in WP(C)No. 5610/2018(A) have directed to appoint Shri. K. Prabhakaran, Advocate, Roll No. K/243/1985, as Special Public Prosecutor to conduct trial in C.C. No.1264/2011 of Judicial First Class Magistrate Court- I, Hosdurg in terms of the Kerala Law Officers (Appointment and Condition of Service) and conduct of cases Rules, 1978, without any financial obligation/burden on the State Government. It has further been ordered that the Home Department shall fix the remuneration in consultation with the Special Public Prosecutor and the Petitioner shall deposit the entire remuneration that may be fixed by the Home Department to the petitioner within thirty days from the date of its fixation. Government have therefore decided to appoint Shri K. Prabhakaran, Advocate, Roll No.K/243/1985, Room No.14, Navarang Building, Kanhangad, Kasaragod District, who is having the requisite qualification as Special Public Prosecutor for the conduct of prosecution of the C.C. No.1264/2011 pending before the Judicial First Class Magistrate Court-1, Hosdurg (Crime No.402/2010 of Hosdurg Police Station), on condition that no remuneration shall be paid by the Government in this regard.

The notification is intended to achieve the above object.
