ORDER

Government vide G.O read above has sanctioned Rs. 17 lakh for the implementation of various protection related schemes and thereafter to undertake various steps for devising appropriate strategies to ensure proper protection of flora and fauna with regard to the meeting of the Forest Ministers of South India on 06.08.2015 by meeting the expenditure from the head of account 2406-01-101-81 Forest Protection 34-OC (plan) in the current year's budget.

The Principal Chief Conservator of Forests (D&PFM) as per the letter read above has reported that in order to carryout various functions by different committees some advances have to be made available to them before 06.08.2015. Due to treasury restrictions all these activities could not be carried out and therefore it was found essential to deposit the amount of Rs. 17 lakhs already sanctioned for the implementation of various protection related schemes in connection with the meeting of the Forest Ministers of South India on 06.08.2015 and has hence deposited the amount in the account of State Forest Development Agency. The Principal Chief Conservator of Forests (D&PFM) has therefore requested to ratify his action.

Government have examined the matter in detail and are pleased to ratify the action of the Principal Chief Conservator of Forests (D&PFM) in having deposited the amount of Rs. 17 lakhs (Rupees Seventeen Lakh only) sanctioned for implementing various related schemes in connection with the meeting of the Forest Ministers of South India scheduled on 06.08.2015 as requested by him.
