ORDER

Shri. N. ShamsulHuda retired from service on 30.06.2007 as Deputy Conservator of Forest(NC). At the time of his retirement, four disciplinary actions and other liabilities were pending. Hence his DCRG was withheld upto finalization of disciplinary cases. In two cases he had been exonerated and in two of them Government had proposed reduction in pension. As per the Government Order read as first paper above one of his disciplinary actions was finalised by imposing a punishment of reduction of Rs. 300/- from his monthly pension permanently. As per the Government Order read as second paper above another disciplinary action was finalised by imposing a punishment of reduction of Rs. 300/- from his monthly pension permanently and to recover Rs. 3,78,420/-from him. The Additional Principal Chief Conservator of Forests (Development) who is the authority to quantify the unsettled advance, has informed that Rs.3,71,452/- is still pending against him as part of miscellaneous advance taken by him during his service. Thus his quantified liability became Rs. 7,49,872/-. His admitted amount of DCRG is Rs. 3,00,050/-. Hence the entire DCRG was adjusted towards his liability and ordered to recover the balance liability through Revenue recovery or civil proceedings and therefore the DCRG

was not released.

- 2) Against this he filed various cases. As per the order read as third paper above, the Hon'ble Kerala Administrative Tribunal set aside the Government Orders cited (1) & (2) above and ordered to release the entire pensionary benefits of the applicant including DCRG, together with interest at 9% per annum on the amount of DCRG from 01.01.2009 till the date of payment.
- 3) Government have examined the matter in detatil and accord sanction to release the entire pensionary benefits including DCRG together with interest at 9% per annum on the amount of DCRG from 01.01.2009 till the date of payment to Shri.N. ShamsulHuda, Deputy Conservator of Forest(NC) (Rtd.). The judgement of Hon'ble Kerala Administrative Tribunal in TA.No.6567/2012 filed by Shri.N. ShamsulHuda, Deputy Conservator of Forest(NC) (Rtd.) is thus complied with. Additional Principal Chief Conservator of Forests (Admn.) shall take urgent necessary steps in this regard.
