## NOTE FOR COUNCIL OF MINISTERS

This file deals with the creation of 101 posts in 12 departments in the Government Medical College (Institute of Integrated Medical Sciences), Palakkad and to make appointments on Contract/daily wage basis for starting OP Section from January 2021.

2. The Director, Institute of Integrated Medical Sciences has informed that in order to start OP Section in 12 departments from January 2021, the following posts are to be created.
