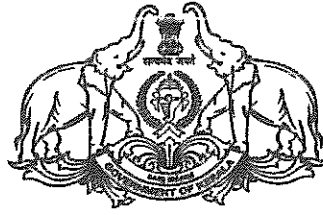

In exercise of the powers conferred by sub section (1) of section 2 of the Kerala Public Service Act, 1968 (19 of 1968), the Government of Kerala hereby make the following rules further to amend the Special Rules for Financial Assistants and Finance Officers in the Various Departments of the State of Kerala, issued under Notification G.O.(P) No. 327/91/Fin. Dated 1st April, 1991 and published as S.R.O. No. 788/91 in Part I of the Kerala Gazette No. 21 dated the 21st May, 1991.



RULES

1. *Short title and commencement.*- (1) These rules may be called the Financial Assistants and Finance Officers in the Various Departments of the State of Kerala (Amendment) Special Rules, 2019.

(2) In these rules,-

(a) Sub-rules (1) and (3) of rule 2 shall be deemed to have come into force on the 1st day of April, 2010.

(b) Sub-rule (2) of rule 2 shall be deemed to have come into force on the 1st day of June, 2014.

2. *Amendment of the Rules.*- In the Special Rules for Financial Assistants and Finance Officers in the Various Departments of the State of Kerala, 1991, for rule 6, the following rule shall be substituted, namely:-

“6. *Probation.*- (1) Every person appointed by promotion to the category of Financial Assistant under these rules shall, from the date on which he joins duty, be on probation for a total period of six months on duty within a continuous period of one year.

(2) In the case of Financial Assistants appointed by the method of recruitment by transfer shall, from the date on which he joins duty as Financial Assistant, be on probation for a total period of one year on duty within a continuous period of two years.

(3) In the case of persons appointed to the categories of Finance Officer and Senior Finance Officer, the period of probation shall be six months on duty within a continuous period of one year from the date of assumption of charge in each cadre.”

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G.O.(P)No. 42/2010/P&ARD. dated 20th December 2010, the period of probation of persons appointed to selection posts in the State Service by promotion and appointed thereto by-transfer within the Department where direct recruitment is not one of the methods of appointment as per the Special Rules, shall be fixed as six months on duty within a continuous period of one year and as per G.O.(P)No. 73/2016/Fin. dated 20th May 2016, the period of probation of Financial Assistants appointed by the method of recruitment 'by transfer' shall be one year within a period of two years with effect from 1st June 2014. Therefore rule 6 of the Special Rules for Financial Assistants and Finance Officers in various Departments of the State of Kerala, 1991 has to be amended suitably.

The notification is intended to achieve the above object.
