ORDER

The Principal Chief Conservator of Forest (Forest, Land & Resources) & Nodal Officer as per the letter read 1st paper above has recommended and forwarded the proposal for diversion of 0.0129 ha of forest land under section 2 of Forest (Conservation) Act, 1980 for electrification of Thazhethotti area of Karimannoor Grama Panchayath in Idukki District falls in Kothamangalam Forest Division under total electrification scheme. The Executive Engineer, Electrical Division, KSEBL, Thodupuzha is the User Agency. The proposal is for laying LT Single phase UG cable with (length 430 M x width 0.3 M x depth 0.9 M) and the proposed electric cable is passing through the coupe road of 1957, 1949 teak plantations in Kaliyar Range of Kothamangalam Division. This project is for providing electricity to 6 families of Thazhethotti area in Karimannoor Grama Panchayath.

- 2. Government have examined the matter in detail on the basis of the guidelines issued by the Government of India as per the letter read 2nd paper above and are pleased to accord sanction for the above proposal subject to the following conditions:-
- 1. Legal status of the forest shall remain unchanged.
- 2. The User Agency shall given an undertaking to pay Net Present Value as per guidelines issued by Government of India.

3. The User Agency shall give an undertaking to pay additional Ne Present Value if required.

4. The User Agency shall make online payment of Net Present Value ad-hoc CAMPA through e-payment module of forest clearance portain (forestclearance nicin).

5. The User Agency shall not fell any frees if demanded or cause damage to the surrounding forest and shall take all possible measures to

conserve tree growth.

6. The User Agency shall not use the forest land for any purpose.

7. When the forest land is no longer required for the purpose, the land will be resumed back to the Forest Department.

8. The User Agency shall abide by any other condition imposed later on by Government of India/Government of Kerala/Forest Department in the

interest of Forest Conservation.

9. The User Agency shall apply for renewal of approval after 10 years.

10. The User Agency has to sign an agreement with Divisional Forest Officer, Kothamangalam incorporating all the conditions imposed by Government of India/Government of Kerala/Kerala Forest Department in this regard and a nominal lease rent as decided by the Government of Kerala may be remitted.
