**ORDER**

As per the Government Order read as 1<sup>st</sup> Paper above the seigniorage rate of timber, firewood and other forest produces were revised for the period from 01.04.1998 to 31.03.1999. There was no revision of seigniorage rates for the period from 01.04.1999 to 31.03.2007. As per the meeting held on 18.02.2006, it was decided that the seigniorage rate fixed for the year 1998-99 will continue to be in force till further revision. But no Government Order was issued to that effect. As per the Government Order read as 3<sup>rd</sup> paper above seigniorage rate of timber and other forest produces were again revised for 2007-08 and 2008-09.

2) Now Government are pleased to order that the seigniorage rate fixed for the year 1998-1999 as per the Government Order read as 1<sup>st</sup> paper above would continue in force till the next revision of rates issued as per the Government Order read as 3<sup>rd</sup> paper above, ie for the period from 01.04.1999 to 31.03.2007.
