ORDER

The Additional Principal Chief Conservator of Forests (Administration), Thiruvananthapuram as per the letter read as 14th paper above has furnished a proposal for the declaration of probation of Sri.Abdul Assis in the cadre of Assistant Conservator of Forests with effect from the FN of 24/07/2010 and requested Government to issue revised orders, whose period of probation has been declared as one year duty within a continuous period of two years, who were appointed by transfer before the issuance of revised Special Rules as per the G.O read as 13th paper above.

Government have examined the proposal in detail and are pleased to declare that Sri.Abdul Assis, Assistant Conservator of Forests has

satisfactorily completed the period of probation in the cadre of Assistant Conservator of Forests with effect from the FN of 24/07/2010. The following Assistant Conservator of Forests whose probation were declared to have satisfactorily completed treating of period of probation as 1 year duty vide orders read as 1st to 12th papers above is now revised. These Officers period of probation is also extended to two year duty within a continuous period of 3 years similar to that of Sri.Abdul Assis, ACF as ordered in para 1 above. As they were appointed before the Special rule, vide G.O read as 13th paper above, the declaration of probation of the officers are revised with effect from the date noted against their names.
