Explanatory Note

Suresh as the Chairperson of the Kerala State Commission for Protection of Child Rights as per notification issued under G.O (P) No.13/2018/SJD dated 29th September, 2018 and published as S.R.O No.684/2018 in the Kerala Gazette Extraordinary No.2476 dated 29th September, 2018.
