In exercise of the powers conferred by clauses (2) and (3) of Article 166 of the Constitution of India, the Governor of Kerala hereby makes the following rules further to amend the Rules of Business of the Government of Kerala, namely:--



RULES

- 1. Short title and commencement.- (1) These rules may be called the Rules of Business of the Government of Kerala (Amendment) Rules, 2021.
 - (2) They shall come into force at once.
- 2. Amendment of the Rules.- In the Rules of Business of the Government of Kerala, in PART II, in the FIRST SCHEDULE,-
 - (1) under the heading "List of Departments",--
- (a) after serial number and entry "30. Power Department", the following serial number and the entry shall be inserted, namely:--
 - "31. Programme Implementation, Evaluation and Monitoring Department";
- (b) the existing serial numbers from 31 to 44 shall be renumbered consecutively from 32 to 45;
- (2) under the heading "DISTRIBUTION OF BUSINESS AMONG DEPARTMENTS OF THE SECRETARIAT",-
- (a) under the sub-heading "XXIX. PLANNING AND ECONOMIC AFFAIRS DEPARTMENT", for the existing entries, the following entries shall be substituted, namely:--

"A. Planning

- 1. Department of Economics and Statistics.
- 2. Data Base and digitisation of data for Planning.
- 3. Economic and Financial Policy issues including Centre State Financial Relations.
- 4. Economic Survey and studies for preparing the survey including study of the State and Central Budget and preparation of yearly review on the level of taxation and related matters.
- 5. N.D.C. and its committees.
- 6. Formulation of Development Plans, Perspective Plans, Five Year Plans and Annual Plans.
- 7. Integration of physical, economic, social and environmental planning.
- 8. Examination of schemes/projects to be included in the plans.
- 9. Plan Resources and Mobilisation.
- 10. Multilevel Planning; State, District, Block and local levels.



- 11. Manpower and Employment Planning.
- 12. Projects; Measures for improving projects formulation, project analysis and appraisal.
- 13. State Planning Board.
- 14. State Land Use Board and Centre for Land Use and Environment Studies.

B. Economic Affairs

- 1. Foreign Assistance and collaboration—Bilateral and U.N. Agencies including IBRD, ADB, etc.
- 2. Institutional Finance; RBI, NABARD, IFC, ICICI, IDBI, LIC, REC, HUDCO, IDC, and similar institutions, Nationalised and other Banks.
- 3. Banking operations relating to Government and allied matters.
- 4 Prices
- 5. Settlement of Assets and Liabilities under S.R Act-Residual matters.
- 6. Work relating to Finance Commission.
- 7. Kerala Technical Consultancy Organisation Ltd.
- 8. Centre for Development Studies.
- 9. Assistance to Research Centres in Planning and Economic Development.

C. Public Enterprises (Bureau of Public Enterprises)

- 1. General Consideration and review of Public Enterprises.
- 2. Public Enterprises Board and allied matters
- 3. Public Enterprises Selection Board";
- (b) after the sub-heading "XXX. POWER DEPARTMENT" and the entries thereunder, the following sub-heading and entries shall be inserted, namely:--

"XXXI. PROGRAMME IMPLEMENTATION, EVALUATION AND MONITORING DEPARTMENT

- 1. Monitoring & Evaluation of all State Plan Schemes including RIDF, EAPs & Major Infrastructure Development Projects, Special Component Plan and Tribal Sub Plan, Central Sector Schemes and Centrally Sponsored Schemes.
- 2. Co-ordination, monitoring and liaising with Central Ministries for Central Assistance



- 3. Review of physical and financial progress of Plan Schemes, Projects and Programmes in the State.
- 4. Monitoring & Evaluation of all infrastructure projects (PPP & non-PPP) including priority projects.
- 5. Implementation and Monitoring of Member of Parliament Local Area Development Scheme (MPLADS) in the State.
- 6. All digital mode of monitoring of Plan Schemes, Projects and Programmes including those of Government of India.
- 7. Implementation and Monitoring of Sustainable Development Goals (SDGs).
- 8. Co-ordination, implementation and monitoring of all NITI Aayog initiatives.
- 9. Monitoring of all Missions in Navakeralam Karmapadhathi and such missions announced by Government.
- 10. District Development Council and monitoring projects through District Development Commissioners.
- 11. Preparation of performance indices of various departments, government agencies and district offices based on effectiveness of programme and project implementation.
- 12. Designing incentives for encouraging performance in programme and project implementation of departments, government agencies and district offices.
- 13. Design and incorporation of state-of the-art methods and processes into the planning, implementation, evaluation and monitoring systems of departments, government agencies and district offices.
- 14. Inducting professional management services and resources for programme and project implementation.";
- (c) The existing serial numbers prefixing the sub heading from XXXI to XLIV shall be renumbered consecutively from XXXII to XLV.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per GO(Ms.) No. 105/2021/GAD dated 21st May 2021, orders were issued for forming a new independant department for the implementation, evaluation and monitoring of the mega projects and the programmes under the Government. Accordingly, the Government have decided to make necessary amendments in the Rules of Business of the Government of Kerala for modifying the existing subjects allotted under the Planning and Economics Affairs Department and for incorporating the name and subjects allotted under the new department "Programme Implementation, Evaluation and Monitoring Department".

The notification is intended to achieve the above object.
