In exercise of the powers conferred by section 4 of the Kerala Public Service Commission (Additional Functions as respects certain Corporations and Companies) Act, 1970 (19 of 1970), the Government of Kerala hereby make the following rules further to amend the Kerala Public Service Commission (Consultation by Corporations and Companies) Rules, 1971, issued by notification under G.O.(Ms.)No.129/71/PD dated 11<sup>th</sup> May, 1971 and published as S.R.O.No.145/71 in the Kerala Gazette Extraordinary No.245 dated 11<sup>th</sup> May, 1971, namely:-



#### RULES

1. *Short title and commencement.*- (1) These rules may be called the Kerala Public Service Commission (Consultation by Corporations and Companies) Amendment Rules, 2021.

(2) They shall come into force at once.

2. *Amendment of the Rules.*- In the Kerala Public Service Commission (Consultation by Corporations and Companies) Rules, 1971, in clause (d) of rule 2, after item (cvi), the following items shall be added, namely:-

"(cvii) Bekal Resorts Development Corporation Limited.

(cviii) Kerala Tourism Infrastructure Limited ".

### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

The Bekal Resorts Development Corporation Limited and The Kerala Tourism Infrastructure Limited are Government Companies as defined in clause (b) of section 2 of the Kerala Public Service Commission (Additional Functions as respects certain Corporations and Companies) Act, 1970 (19 of 1970). It is considered necessary to include these companies also in the Kerala Public Service Commission (Consultation by Corporations and Companies) Rules, 1971 so that these companies may seek the advice of the Kerala Public Service Commission on matters relating to the methods of recruitment of its employees.

The notification is intended to achieve the above object.
