S. R. O. No. 620/2016.—In exercise of the powers conferred by clauses (2) and (3) of article 166 of the Constitution of India, the Governor of Kerala hereby makes the following rules further to amend the Rules of Business of the Government of Kerala, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Rules of Business of the Government of Kerala (Amendment) Rules, 2016.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Rules of Business of the Government of Kerala, in Part II, in the FIRST SCHEDULE, under the heading DISTRIBUTION OF BUSINESS AMONG DEPARTMENTS OF THE SECRETARIAT,—

(i) under the sub-heading “X. ENVIRONMENT DEPARTMENT”, for the entries against serial number 11, the following entries shall be substituted, namely:—

“Kerala Coastal Zone Management Authority and allied matters”;

(ii) under the sub-heading “XXXIV. SCIENCE AND TECHNOLOGY DEPARTMENT”, serial number 5 and the entries against it shall be omitted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The subject, “Kerala Coastal Zone Management Authority and allied matters except its Administrative Control” is being dealt within the Science and Technology Department and Administrative control of Kerala Coastal Zone Management Authority is being dealt under the Environment Department. Now the Government have decided to transfer the subject

Kerala Coastal Zone Management Authority and allied matters to the Environment Department. Corresponding amendments to the Rules of Business is necessary to effect the change. Hence the Government have decided to amend the Rules of Business of the Government of Kerala for the above said purpose.

The notification is intended to achieve the above object.
