ORDER

In the letter read as 1st paper above, Malayala Manorama had expressed their willingness to co-operate with the Forest Department for the continuation of the Bhoomikkoru Kuda programme, an awareness campaign for tree planting. As per the letter read 2nd above the Principal Chief Conservator of Forests(Social Forestry) has reported that the Malayala Manorama had expressed their willingness to co-operate with the Forest Department and Kerala Forest Department have to sign a Memorandum of Understanding (MOU) between them for the successful implementation of the scheme.

2. The Principal Chief Conservator of Forests (Social Forestry) has therefore submitted a proposal to supply seedlings at free of cost to Malayala Manorama and also for transportation of the seedlings at the cost of the Forest Department to the venues decided by them for further distribution. The Principal Chief Conservator of Forests (Social Forestry) has reported that 10.00 lakhs of seedlings were supplied to Malayala Manorama and the financial commitment for this including transportation charge is approximately Rs.40.00 lakhs (Forty Lakhs) as explained below:-

Government have examined the matter in detail and are pleased to accord sanction for the Memorandum of Understanding (MOU) between Forest Department and Malayala Manorama for the tie up programme of tree planting under 'Bhoomikkoru Kuda' programme and for supply of 10.00 lakhs seedlings at a total cost of Rs. 40.00 lakhs (Forty Lakhs) meeting the expenditure from the concerned head of account.
