ORDER

As per order read as first paper above, disciplinary action initiated against Shri.C.T.Joju, while he was working as Range Forest Officer, Walayar Range, in connection with the illicit felling and removal of huge "Thanni" trees was finalized by imposing a penalty of barring one increment without cumulative effect and recovery of Rs.23,807/- towards Government loss. In the appeal petition submitted by Shri.C.T.Joju, Government, as per the Government Order read 2nd paper above, reduced the penalty to 'censure' and recovery of proportionate Government loss of Rs.23,807/-.

As per the Government Order read as 3rd paper above, Government have rejected the review petition submitted by Sri.C.T.Joju. Aggrieved by this Sri.C.T.Joju filed O.A. 1240/19 before the Hon'ble Kerala administrative Tribunal.

As per the order read as 4th paper above, the Hon'ble Kerala Administrative Tribunal set aside the Government order read as 2nd paper above imposing penalty of 'censure' and recovery of Government loss and declared that the applicant stands exonerated of the charges.

In the above circumstances, Government hereby issue orders exonerating Sri.C.T.Joju, Deputy Conservator of Forests (Rtd.) from the charges levelled against him in the disciplinary action. The order of the Hon'ble Kerala administrative Tribunal read as 4th paper above is complied with accordingly.
