ORDER

As per the Government Order read above, Government have accorded Administrative Sanction for the implementation of Haritha keralam Phase X during the period 2017-18 and 2018-19.

The Principal Chief Conservator of Forests (Social Forestry) as per his letter read as second paper above, has furnished the Action Plan for distributing seedlings free of cost to educational institutions and planting in public lands and supply of seedlings at a subsidised rate to Local Self Government bodies, media, public and other organizations, under Haritha Keralam Phase XI during the period 2018-19 and 2019-2020 and has requested to accord administrative sanction for the implementation of the Action Plan utilizing an amount of Rs.1185.18 Lakh under the head of account 2406-01-800-55(01) Extension Forestry (Plan) under State Plan Scheme 2019-20.

The Special Working Group met on 11.06.2019 scrutinized and approved the following Proposal.

4. Tender/e-tender and other stipulated formalities shall be followed wherever necessary,

5. Post creation and purchase of vehicles are not admissible under the scheme.
