O., Vadayampady, Ernakulam-682 308 as a member of the Kerala Women’s Commission in the existing vacancy due to the resignation of Prof. K. A. Thulasi, Krishna Nivas, Shornur, Palakkad District, PIN-679 121 and make the following consequential amendment to the

No. 228/2012/SWD in the Kerala Gazette Extraordinary No. 683 dated 3rd April, 2012, as amended by notification issued under G.O. (P) No. 43/2012/SWD dated 12th July, 2012 and published as S.R.O. No. 503/2012 in the Kerala Gazette Extraordinary No. 1489 dated 12th July, 2012 and as further amended by notification issued under G.O. (P) 51/2012/SWD dated 25th August, 2012 and published as S.R.O. No. 603/2012/SWD in the Kerala Gazette Extraordinary No. 1779 dated 27th August, 2012 and consequently make the following amendment to the said notification, namely:—

AMENDMENT

In the said notification, for serial number 4 and the entries against it, the following shall be substituted, namely:—

The term of appointment of the member shall be for the remaining period of the term of the person in whose place the member has been appointed as per sub-section (3) of section 6 of the Kerala Women's Commission Act, 1991.

Explanatory Note

(This does not form part of notification, but is intended to indicate its general purport.)

The Kerala Women's Commission was re-constituted with Smt. K. C. Rosakkutty Teacher as Chairperson and Adv. P. K. Noorbina Rasheed, Dr. Prameela Devi, J. and Dr. Lissy Jose as members as per the notification issued under G. O. (P) No. 22/2012/SWD dated 3rd April, 2012 and published as S.R.O. No. 228/2012/SWD in the Kerala Gazette Extraordinary No. 683 dated 3rd April, 2012, as amended by notification issued under G. O. (P) No. 43/2012/SWD dated 12th July, 2012 and published as S.R.O. No. 503/2012 in the Kerala Gazette Extraordinary No. 1489 dated 12th July, 2012. As per section 5 of the Kerala Women's Commission Act, 1991 (Act 17 of 1995) the Kerala State Women's Commission shall consist of a Chairperson and not more than four other members, of whom one shall be a woman belonging to a Scheduled Caste or a Scheduled Tribe. Now Prof. K. A. Thulasi resigned from holding the office as a member of the Commission and Government accepted her resignation as per G. O. (Ms.) No. 36/2016/SWD dated 21st April, 2016. Government propose to fill up the vacancy by appointing Adv. Shiji Sivaji, Kottackal House, Vadayampady P.O., Vadayampady, Ernakulam under sub-section (3) of section 6 of the said Act.

The notification is intended to achieve the above object.
