ORDER

As per Paragraph 2 (1) of the Circular read 2nd paper above, it was instructed to the Administrative Department concerned to designate a Single Nodal Agency (SNA) for implementing each CSS before June 2021. The SNA will open a Single Nodal Account for each CSS at the State level in a Scheduled Commercial Bank (except Foreign Banks) like State Bank of India, other Nationalised Banks, Regional Rural Banks, Other Scheduled Commercial Banks (Private Banks) before 15 June 2021.

Subsequently, as per letter read as 3rd paper above the Principal Chief Conservator of Forests (Planning & Development) has proposed Single Nodal Agency (SNA) for each Centrally Sponsored Schemes (CSS) of Forest Department and requested Government Order designating the SNA's for the implementation of various CSS under Forest Department.

Government have examined the matter in detail and are pleased to order to designate Single Nodal Agency (SNA) and their corresponding Centrally Sponsored Schemes (CSS) **as mentioned in Annexure** to the order for the implementation of CSS's of Forest Department as per the instructions / guidelines issued in the Government Order and Circular read 1st and 2nd papers above.
