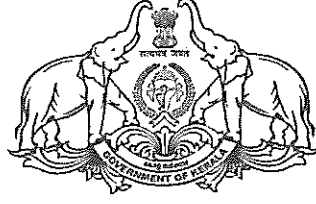

In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala, hereby make the following rules further to amend the Kerala Service Rules, namely:-

RULES

1. *Short title and commencement.*- (1) These rules may be called the Kerala Service (Second Amendment) Rules, 2020.

(2) They shall be deemed to have come into force on the 27th day of May, 2019.

2. *Amendment of the Rules.*- In Part III of the Kerala Service Rules, for the words "Pension Payment Order", wherever they occur, the words and symbols "Pension Payment Order/e-Pension Payment Order" shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G.O.(P)No.61/2019/Fin. dated 27th May, 2019, the Government have decided to implicate e-Pension Payment Order methodology in the State. As a part of Integrated Financial Management, from 1 st June 2019 onwards the Accountant General has been issuing authorisation of pension through e-Pension Payment Order consequent to the issuance of the above executive order. To give statutory validity to the provisions contained in the above said Government Order, the Government have now decided to amend Part III of the Kerala Service Rules suitably.

The notification is intended to achieve the above object.
