ORDER

National Mission for Green India (GIM) is one of the eight National Mission for Combating Climate Change. The overall objective of GIM is afforestation and eco restoration by increasing forest cover and enhancing the quality of existing forests.

The Principal Chief Conservator of Forests (D & PFM)) vide letter read above has requested Government to issue orders to release 40% state share equivalent to first release of central share amounting to ₹ 609.88 lakhs (Rupees six crores nine lakhs and eighty eight thousand only) under the Budget head 2406-01-102-86-NAP-National Mission for a Green India along with the central share of ₹ 914.82 lakhs (Rupees Nine Crores fourteen lakhs and eighty two thousand only) which has already been released as first instalment to the State, for the implementation of the approved physical target for the year 2015-16 for carrying out GIM activities in 4978 ha under five sub missions and to provide alternative fuel energy to 12129 householdes with a total financial implication of ₹ 2800.47 lakhs shared between Central and State Government in the ratio 60:40

Government after examining the matter in detail are pleased to issue Orders to release central share of ₹ 914.82lakth (Rupees Nine Crores fourteen lakhs and eighty two thousand only) along with state share of ₹ 609.88 lakhs (Rupees six crores nine lakhs and eighty eight thousand only) from the budget provision available under the h/a 2406-01-102-86 National Afforedtation - **National Mission for Green India** during 2016-17 financial year as first instalment and to transfer the sum to the bank a/c of State Forest Development Authority (SFDA) subject to the condition that transfer shall be limited to ₹ 5 crores at a time.


