S. R. O. No. 313/2014.—In exercise of the powers conferred, under section 3 read with clause (c) of section 2 of the Kerala Marine Fishing Regulation Act, 1980 (10 of 1981), and in supersession of the Notification issued under G. O. (P) No. 10/99/F&PD dated 31st March, 1999 and published as S.R.O. No. 325/99 in the Kerala Gazette Extraordinary No. 715 dated 7th April, 1999 the Government of Kerala hereby authorise the officers specified below to exercise the powers conferred on and discharge the duties imposed upon the authorised officer under sections 14 and 15 of the said Act, with jurisdiction over the whole State of Kerala.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per section 3 of the Kerala Marine Fishing Regulation Act, 1980, the Government may empower officers not below the rank of a Gazetted officer to exercise the powers conferred on and to discharge the duties imposed upon the authorized officers under the Act. Accordingly, Government have issued G. O. (P) No. 10/99/F&PD dated 31st March, 1999 and published as S. R. O. No. 325/99 in the Kerala Gazette Extraordinary No. 715 dated 7th April, 1999. Some posts mentioned in the said notification have been abolished. Hence it has become necessary to revise the said notification, and accordingly Government have decided to issue a new notification authorizing the officers to carry out the purposes of the Act.

The notification is intended to achieve the above object.
