ORDER

As per the Government Order read as 1st paper above, Administrative sanction was accorded for the Ist phase of the work "Modernization of Forest Head Quarters Building" for an amount of Rs.1,68,96,000/- by entrusting the work with BSNL as a deposit work by incurring the expenditure under the Head of account "2406-01-101-84-Priority Schemes under 13th FC Award".

- 2) As per the Government Order read as 2nd paper above, Phase II & III work of the same project was sanctioned for an amount of Rs.4,22,27,000/- with the direction to adequate provision for fire sensors and fire extinguishers.
- 3) The Additional Principal Chief Conservator of Forests (Admn.) as per the letter read as 3rd paper above has sought for Government sanction to deposit an additional amount of Rs.77,22,303/- to the Chief Engineers of Civil Division and Electrical Division, in addition to the amount in Administrative sanction for completion of ongoing works including installation of sprinkler system in the fire fighting system.
- 4) The Additional Principal Chief Conservator of Forests (Admn.) as per the letter dated 10.03.2015 read as 3rd paper above has clarified that out of the total amount of Rs.1048.23 lakh provided for Modernization of Offices under 13th FC Award an amount of Rs.686.93 lakh was got alloted for the Modernization of Forest Head Quarters Building from 2011-12 to 2014-15 ie. the required amount is within the alloted amount for the purpose.
- 5) Government examined the matter in detail and are pleased to accord revised sanction for a total amount of Rs.6,68,45,303/- (Six crore sixtyeight lakhs fortyfive thousand three hundred and three only) in place of the already sanctioned amount of Rs.5,91,23,000/-

(Rupees Five crore ninetyone lakhs twentythree thousand only) for Modernization of Forest Head Quarters building as per the Government Orders read above, subject to the condition that the total cost will not exceed the approved amount in Action Plan for this item of expenditure.
