and published as S.R.O.No.14/2021 in the Kerala Gazette Extraordinary No.25 dated 4th January, 2021 and as per notification issued under G.O.(Ms.)No.4/2021/Home dated 4th January, 2021 and published as S.R.O.No.13/2021 in the Kerala Gazette Extraordinary No.24 dated 4th January, 2021 for a period of two years with effect from the date on which they assume charge as such.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Sub-section (1) of section 32 of the Protection of Children from Sexual Offerces Act, 2012 (Central Act 32 of 2012) provides that the State Government shall, by notification in the Official Gazette, appoint a Special Public Prosecutor for every Special Court for conducting cases under the provisions of the said Act. Government as per G.O.(Ms.)No.93/2020/Home dated 24th April, 2020 have accorded sanction to establish 28 Fast Track Special Courts (FTSCs) in 14 districts for the speedy disposal of rape cases and cases registered under Protection of Children from Sexual Offences Act, 2012 (Central Act 32 of 2012) in the State on temporary basis for a period of two years out of which four Fast Track Special Courts were established at Thrissur, Irinjalakkuda, Thiruvananthapuram and Nedumangad as per G.O.Ms.)No.3/2021/Home dated 4th January, 2021 and published as S.R.O.No.14/2021 in the Kerala Gazette Extraordinary No.25 dated 4th January, 2021 and G.O.(Ms.)No.4/2021/Home dated 4th January, 2021 and published as S.R.O.No.13/2021 in the Kerala Gazette Extraordinary No.24 dated 4th January, 2021.

Government considers it necessary to appoint Special Public Prosecutors, who are having the requisite qualification to be appointed as Special Public Prosecutor in the Fast Track Special Courts for the conduct of rape cases and cases under the Protection of Children from Sexual Offences Act, 2012 (Central Act 32 of 2012). The appointment shall be subject to the result of Writ Petitions/Writ Appeals, if any, pending before any court of law in this regard.

The notification is intended to achieve the above object.
