### ORDER

As per Government Order read as 1<sup>st</sup> paper above, Administrative Sanction was accorded for an amount of Rs.1,07,55,375/- for the renovation of Forest Museum PTP Nagar as Natural History Museum upto 2013-14 under the Head of Account '2406-01-800-99-Forest extension and Publicity-34-OC (Plan)'.

(2) Additional Principal Chief Conservator of Forest (IHRD), vide letter read as 2<sup>nd</sup> paper above, has sought sanction for revalidating the administrative sanction for the year 2014-15.

(3) Vide letter read as 3<sup>rd</sup> paper above, Government have issued directions to keep the proposed Natural History Museum at PTP Nagar itself and to submit fresh proposals for getting the administrative sanction revalidated for the year 2015-16.

(4) Vide letter read as 4<sup>th</sup> paper above, Additional Principal Chief Conservator of Forest (IHRD), has requested to accord revised Administrative Sanction for completing the balance work of Natural History Museum.

(5) The Departmental Working Group Meeting held on 18/8/15, considered the request of Additional Principal Chief Conservator of Forest (IHRD) and agreed to give revised Administrative Sanction meeting the expenditure from the fund for 'Nature appreciation Centre' for completing the work subject to the following conditions;

1. Project will be completed within 31<sup>st</sup> December, 2015
2. Additional Principal Chief Conservator of Forest (IHRD) will be responsible for implementing the whole work
3. All the works should be accountable

(6) Based on the decision taken in the Departmental Working Group Meeting, Government are pleased to accord revised Administrative Sanction for Rs.75/- lakh from the changed Budget Head '2406-01-800-55-01-Extension Forestry (P) for completion of the balance work of Natural History Museum by meeting the expenditure from the fund 'Nature appreciation Centre' subject to the following conditions;

1. Project will be completed within 31<sup>st</sup> December, 2015.
2. Additional Principal Chief Conservator of Forest (IHRD) will be responsible for implementing the whole work.
3. All the works should be accountable.
