**S. R. O. No. 195/2019.**—In exercise of the powers conferred by section 4 of the Kerala Public Service Commission (Additional Functions as Respects Certain Corporations and Companies) Act, 1970 (19 of 1970), the Government of Kerala hereby make the following rules further to amend the Kerala Public Service Commission (Consultation by Corporations and Companies) Rules, 1971, issued by notification under G. O. (Ms.) No. 129/71/PD dated 11th May, 1971 and published as S. R. O. No. 145/71 in the Kerala Gazette Extraordinary No. 245 dated 11th May, 1971, namely:—

## RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Public Service Commission (Consultation by Corporations and Companies) Amendment Rules, 2019.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Kerala Public Service Commission (Consultation by Corporations and Companies) Rules, 1971 in clause (d) of rule 2, after item (cv), the following item shall be added, namely:—

“(cvi) Kerala State Women’s Development Corporation Limited.”.

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Kerala State Women’s Development Corporation Limited is a Government Company as defined in clause (b) of section 2 of the Kerala Public Service Commission (Additional Functions as Respects Certain Corporations and Companies) Act, 1970 (19 of 1970). It is considered necessary to include this company also in the Kerala Public Service Commission (Consultation by Corporations and Companies) Rules, 1971 so that this company may seek the advice of the Kerala Public Service Commission on matters relating to the methods of recruitment of its employees.

The notification is intended to achieve the above object.
