S. R. O. No. 61/2018.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Kerala Service Rules, namely:—

Rules

- 1. Short title and commencement.—(1) These rules may be called the Kerala Service (First Amendment) Rules, 2018.
 - (2) They shall come in to force at once.

- 2. Amendment of the Rules.—In Part III of the Kerala Service Rules, in clause (d) of rule 25,—
- (i) in the first sentence, after the words "Port Officers" the words "or Engineers in Charge" shall be inserted;
- (ii) in the last sentence, after the words "Port Officers" the words "and Engineers in Charge" shall be inserted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government have decided to extend the benefit of reckoning for superannuation pension but not for any other kind of pension, the actual period of service in Merchant Navy or in organisations like the Major Port Trusts of India not exceeding five years to Engineers in Charge in Ports Department also.

In order to give statutory validity to the above decision, suitable amendment has to be made to Part III of the Kerala Service Rules.
