ORDER

As per Government Order read as Ist paper above, Government have accorded sanction for the engagement of Sri.T.L.V.Iyer, Senior Advocate, Hon'ble Supreme Court of India for getting legal opinion on the sustainability and enforcement of Kerala Fishermen's and Allied Workers Welfare Cess Act, 2007 with special reference to the points mentioned therein. .

2) As per the letter read as 2nd paper above Shri.T.L.V.Iyer , Sr.Advocate, has rendered legal opinion on the enforceability of Fisherrmen's and Allied Workers Welfare Cess Act, 2007.

3) As per the letter read as 3rd paper above, he has requested payment for an amount of Rs. 1,11,000/- for the legal opinion furnished alongwith bill for the amount. The Advocate General Ernakulam has recommended for payment of the amount as per his letter 5th read above.

4) The Director of Fisheries as per letter read as 4th paper above, has reported that the expenditure towards payment of the amount of Rs. 1,11,000/- may be met from the current years' budget provision under the Head of Account 2405-00-800-97-34 OC(P).

5) Government have examined the matter in detail. Accordingly Government are pleased to revalidate the orders issued in the Government Order read as Ist paper above and also accord sanction for the payment of Rs.1,11,000/-(Rupees One Lakh Eleven Thousand Only) to Sri. T.L.Viswanath Iyer, Senior Advocate, Kochi for his service rendered by providing legal opinion on the enforceability of Fishermen's and Allied Workers Welfare Cess Act, 2007 by meeting the expenditure from the current year's budget provision under the Head of Account 2405-00-800-97-34 OC (Plan).
