ORDER

Agasthyavanam Biological Park Project is a comprehensive Project for afforestation, eco-restoration, conservation of wildlife and wildlife tourism in a degraded forest area of nearly twenty three (23) Sq. KMs. in extent in the Kottur Reserve of Paruthippally Forest Range in Thiruvananthapuram Forest Division. An amount of Rupees Five Crores (Rs.5,00,00,000/-) has been included in the Eighth Five Year Plan for the implementation of the first phase of this Project; and in the annual plan for 1992-93, an amount of Rupees One Crore (Rs. 1,00,00,000/-) has been earmarked for it.

2. Government are now pleased to accord administrative sanction for the implementation of the first phase of the Agasthyavanam Biological Park Project at a cost of Rupees Five Crores only.

3. Government are also pleased to sanction the following temporary post for a period of eleven months from 01-4-1992 for the implementation of the Biological Park Project:
