RULES

**S. R. O. No. 753/2018.**—WHEREAS, it appears to the Government of Kerala that the land specified in the Schedule below is needed or likely to be needed for a public purpose, to wit for the land acquisition to establish an International Research Institute of Ayurveda (IRIA) in Kannur District;

AND WHEREAS, in exercise of the powers conferred in sub-section (1) of section 4 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013

(Central Act 30 of 2013), Government of Kerala have decided to conduct a Social Impact Assessment in the area specified in the Schedule below.

Now, THEREFORE, sanction is accorded to the Social Impact Assessment Unit, Shri Saju V. Itty, Kerala Voluntary Health Services, Kottayam to conduct a Social Impact Assessment Study and to prepare a Social Impact Management Plan as provided in the Act. The process shall be completed within a period of three months in any case.

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Rules has come into force on 19-9-2015 and as per Rule 10 notifying a Social Impact Assessment Unit for conducting Social Impact Assessment Study is required. Requisition has been received for acquiring 311.76 acres of land in Kalyad Village to establish an International Research Institute of Ayurveda (IRIA) in Kannur District.

The notification is intended to achieve the above object.
