### ORDER

As per the Government Order read as 1<sup>st</sup> paper above Administrative sanction was accorded for an amount of Rs.10 crores as the 1<sup>st</sup> phase for the project long term measures to reduce man-animal conflict. Sanction was also accorded for the purchase of 2 Lorries from Ashok Leyland Ltd. at a total cost of Rs.23,45,526/- and 4 Mahindra Bolero Camper Jeeps from Mahindra & Mahindra Ltd at a total cost of Rs.21,67,480/- by meeting the expenditure under the head of account '2406-01-800-56 (P)' for use in Wayanad Wildlife and Nilambur South Divisions vide Government Order read as 2<sup>nd</sup> paper above.

(2) Principal Chief Conservator of Forests (WL) vide letter read as 3<sup>rd</sup> paper above has furnished proposal for the purchase of Body building works of the ready-to-built Truck Chassis (2 numbers) and specially equipping the lorry with extra fittings for the Elephant Squad constituted in Wayanad and Nilambur Divisions.

(3) The Departmental Purchase Committee held on 19.06.2015 considered the proposal and decided to purchase Body building works of the ready-to-built Truck Chassis (2 numbers) and specially equipping the lorry with extra fittings for the

Elephant Squad constituted in Wayanad and Nilambur Divisions from Sri.S.Kannan, Lekshmi Auto Diesel Works, Workshop Owner, Salem Main Road, Mettur Dam at a total cost of Rs.20,97,600/- by meeting the expenditure from the Head of Account "2406-01-800-56 (Plan) Measures to reduce Man Animal Conflict (P)" with the strict observance of Stores Purchase Rules and Orders in force.

(4) Based on the decision taken in the meeting of the Departmental Purchase Committee, Government are pleased to accord administrative sanction for the purchase of 2 numbers of Body building works of the ready-to-built Truck Chassis and specially equipping the lorry with extra fittings for the Elephant Squad constituted in Wayanad and Nilambur Divisions from Sri.S.Kannan, Lekshmi Auto Diesel Works, Workshop Owner, Salem Main Road, Mettur Dam at a total cost of Rs.20,97,600/- (Rs. Twenty Lakh Ninety Seven Thousand and Six Hundred only) by meeting the expenditure from the Head of Account "2406-01-800-56 (Plan) Measures to reduce Man Animal Conflict (P)" with the strict observance of Stores Purchase Rules and Orders in force.
