As per Government Order read as first paper above sanction was accorded for sponsoring fifteen Government Employees for the Post Graduate Diploma in e-Governance. This is a joint venture being offered by Institute of Management in Government (IMG) and Indian Institute of Information Technology and Management- Kerala (IIITMK). The course is of one year duration, with the objective of imparting quality training in the area of e-Governance. Successful candidates sponsered by the Government shall be considered for implementation of e-Governance projects initiated in the state. The course is spread across two semesters of one year duration with an intake of 45 participants. Out of 45 seats, 15 seats are reserved for State Government Officials. The course fee is Rs. 75,000/- (Rupées seventy five thousand only), which will be shared in the ratio 90:10 between the Government and the deputed employee respectively.

The sponsoring of fifteen Government employees for the PGDeG course is intended as a part of capacity building for e-Governance projects implemented in the state. It is also envisaged to develop a pool of human resources within Government with the aim to develop personnel who would be able to manage the IT Divisions of the Government departments.

Selection process for the 4th batch has commenced and will be completed by the end of July 2015. The Director, Kerala State IT Mission has invited applications for the Post Graduate Diploma course in e-Governance, 2015-16 Batch. In this connection following instructions are issued:

1) Head of Departments shall forward a list of nominated candidates with their resume along with No Objection Certificate and testimonials. This should reach the Director, Kerala State IT Mission, ICT Campus, Vellayambalam. Thiruvananthapuram on or before 04-07-15. Ph: 0471-2726881, 2314303. 2)Each Department shall forward nomination of two qualified officers of their department for the above course for the acdemic year 2015-16.

3) While granting NoC, the department should also make a consent that the said employee

would be deputed for one year for the said course in case he/she is selected.

While forwarding the list of candidates

(a) the criteria for the selection should be specified.

(b) Role or project which will be assigned to the candidate on successful completion of the course should also be specified.

5) An undertaking from the Heads of Department to the effect that service of employees who completes the above course shall be fully utilized in an effective manner for e-Governance projects in their respective Departments should also be forwarded along with the nomination.
