S. R. O. No. 268/2015.—In exercise of the powers conferred by clause (c) of sub-section (1) and clause (e) and (h) of sub-section (2) of section 4 of the Kerala Municipality Act, 1994 (20 of 1994), and in partial modification of Notification VI issued under G.O. (Ms.) No. 92/94/LAD dated the 22nd April, 1994, and published as S.R.O. No. 479/94 in the Kerala Gazette Extraordinary No. 361 dated the 22nd April, 1994, and after considering the objections and suggestions received from the

concerned Municipal Council and Grama Panchayats, in the draft preliminary notification No. EM3/13(5)/2014/LSGD dated 25th January, 2015 published in the Kerala Gazette Extraordinary No. 183 dated 25th January, 2015, the Government of Kerala hereby constitute, with effect from the 1st November, 2015, a Municipal Corporation comprising of the areas of Municipal Council and areas of Village Panchayat which required urban nature specified in column (2) of the Schedule below, situated in the district specified in the corresponding entry in column (1) thereof and specify the name and Headquarters as given in the corresponding entries in columns (3) and (4) respectively with boundaries as specified in column (5) of the said Schedule, namely:—
