In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Kerala Service Rules, namely:-



## RULES

1. *Short title and commencement.*- (1) These rules may be called the Kerala Service (Eleventh Amendment) Rules, 2019.

(2) Clause (a) of rule 2 shall be deemed to have come into force on the 23<sup>rd</sup> day of September, 2016 and clause (b) of rule shall be deemed to have come into force on the 17<sup>th</sup> day of March 2018.

2. *Amendment of the Rules.*- In Part III of the Kerala Service Rules, in rule 134,-

(a) for the words “rupees Two” the words “rupees Two hundred and fifty” shall be substituted,

(b) for the words “rupees Two hundred and fifty” the words “rupees Two hundred and sixty five” shall be substituted.

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The fees for duplicate Pension Payment Order was enhanced to ₹ 250/- with effect from 23<sup>rd</sup> September, 2016 vide G.O (P) No.141/2016/Fin. dated 23<sup>rd</sup> September, 2016. Government, vide G.O.(P) No.44/2018/Fin. dated 17<sup>th</sup> March, 2018 had increased the existing fees and charges by five percent with effect from 1<sup>st</sup> April, 2018. To give statutory validity to the above said Government orders, The Government have decided to amend rule 134, Part III of the Kerala Service Rules suitably.

The notification is intended to achieve the above object.
