**ORDER**

The Principal Chief Conservator of Forests (FMIS), vide letter read as 2<sup>nd</sup> paper above, has submitted a proposal for the purchase for the following items;

2) The above proposals were placed before the Departmental Purchase Committee held on 15.12.2015 and the following decisions were taken in the Departmental Purchase Committee.

**Item No.1 : Camera Trap (i)** : agreed to give purchase sanction for 475 Nos. of Camera Traps at a total cost of Rs.89,88,900/- from M/s Wild Wood Technologies by meeting the expenditure from B/H 4406-01-101-99-Forest Protection, on condition that purchase of the item will be effected within 20 days of the date of Government Order.

**Item No. 2 : Camera Trap (ii)** : agreed to give purchase sanction for 10 Nos. of Camera Traps at a total cost of Rs.5,95,540/- from M/s Wild Wood Technologies by meeting the expenditure from B/H 4406-01-101-99-Forest Protection, on condition that purchase of the item will be effected within 20 days of the date of Government Order.

**Item No.3 : Radio Collars** : agreed to give purchase sanction of 7 numbers of Radio Collars at a total cost of Rs.46,85,625/- (Rupees Forty Six Lakh Eighty Five Thousand Six Hundred and Twenty Five only) from M/s.A&S Creations, 6/7, GF, West Patel Nagar, New Delhi-110 008 by pooling excess amount in Sl.No. 4(i) and 4 (ii) of the Government Order issued on 14/5/2015.

**Item No.4 : Drone** : Deferred the proposal and decided to have live demonstrate the drone after which final decision will be taken. Supplier agreed to give live demonstration of Drone in Kottoor on 29.12.2015.

(ii) Sanction to purchase 10 Nos. of Camera Traps at a total cost of Rs.5,95,540/- from M/s Wild Wood Technologies by meeting the expenditure from B/H 4406-01-101-99-Forest Protection, on condition that purchase of the

item will be effected within 20 days of the date of Government Order with the strict observance of Stores Purchase Rules and orders in force.

(iii) Sanction to purchase 7 numbers of Radio Collars at a total cost of Rs.46,85,625/- (Rupees Forty Six Lakh Eighty Five Thousand Six Hundred and Twenty Five only) from M/s. A&S Creations, 6/7, GF, West Patel Nagar, New Delhi-110 008 by pooling excess amount in Sl.No. 4(i) and 4 (ii) of the Government Order issued on 14/5/2015, with the strict observance of Stores Purchase Rules and orders in force.
