- 2. All the rules relating to fixation of pay as per Annexure II of G.O(P)No. 7/2016/Fin dated 20.02.2016 should be strictly followed except service weightage. For service weightage, regular service in KHRWS only will be reckoned.
- 3. The date of effect of revision of pay and allowances, option and time bound Higher grade will be sanctioned as specified in G.O(P)No. 7/2016/Fin dated 20.02.2016. No benefits other than mentioned in this order will be allowed for the staff of KHRWS.
- 4. HRA as specified at para 14 of G.O(P)No. 7/2016/Fin dated 20.02.2016 will be sanctioned. CCA is admissible as specified at para 16 of G.O(P)No. 7/2016/Fin dated 20.02.2016 and it will be limited to employees working in offices situated within city limits.
- 5. Upgradation/creation/redesignation of posts(whether full time, part time, temporary, and contract or daily wages) will not be allowed without prior Government sanction.
- 6. No person shall be appointed (whether full time, part time, temporary and contract or daily wages) without a post created validly through a Government Order.
- 7. Payment of arrears will be decided by the Governing Body, depending upon the financial position of the institution.
- 8. Employees appointed on contract basis are eligible for only basic pay + DA. Other allowances eligible to regular employees will not be sanctioned to them unless otherwise specifically ordered in the contract agreement.

9. The maximum employer contribution in EPF will be calculated @ 12% of Rs. 15000/-(Basis pay + DA) unless otherwise specifically ordered by the Government.

10. The additional expenditure on account of granting of pay revision should be met from the own fund of KHRWS. Government will not provide any financial assistance in this regard.

 The Managing Director will be held responsible for violations in the implementation of revision.

12. The earlier pay fixation of the employees should be verified as per the conditions specified in circular no.12/13/Fin dated 30.01.2013. The penal provision of 18% interest as specified at para 4 of circular no.12/13/Fin dated 30.01.2013 will be applicable for irregular fixation of present pay revision also

## NOTE FOR THE COUNCIL OF MINISTERS

This note relates to the proposal for implementing 10th pay revision to the permanent employees of Kerala Health Research and Welfare Society. The pay and Allowances of permanent employees of KHRWS were last revised as per G.O (MS) No.74/2015//H&FWD dtd. 16/04/2015. As per the recommendations of the 10<sup>th</sup> pay Revision Commission, the Pay and Allowances of the state Government employees were revised as per G.O (P) No. 07/2016/Fin dtd. 20/01/2016. The Managing Director, KHRWS has forwarded a proposal for the implementation of the 10th pay revision to the permanent employees of the society.

- 2. When the file was forwarded to the Finance Department, that Department opined as follows-
  - " 'Finance' agrees the 10  $^{\rm th}$  pay revision of KHRWS subject to the conditions that the expenditure on account of granting of pay revision arrear should be met from the own fund of KHRWS.
