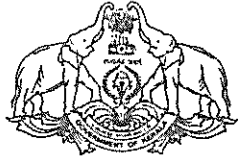

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per notification issued under G. O. (P) No. 44/2013/SJD dated 23rd May, 2013 and published as S.R.O. No. 428/2013 in the Kerala Gazette Extraordinary No. 1458 dated 27th May, 2013, Government of Kerala have constituted the Kerala State Commission for Protection of Child Rights. Clause (b) of sub-section (2) of section 17 of the Commission for Protection of Child Rights Act, 2005 (Central Act 4 of 2006), provides that the State Commission shall consists of six Members other than the Chairperson out of which at least two shall be women from among persons of eminence, ability and integrity from the fields specified in the said section. As per G. O. (P) No. 06/2014/SJD dated 23-1-2014 Government have appointed six Members to the Commission after complying with the provisions in the said Act and the Kerala State Commission for Protection of Child Rights Rules, 2012 made thereunder. Since the term of the Present Members expired on 7-1-2017, Government have decided to appoint six members to the Commission after complying with the provisions in the said Act and the Kerala State Commission for Protection of Child Rights Rules, 2012. The term of office and conditions of service of Members of the Commission shall be as stipulated under section 19 of the said Act and Rule 5 of the said Rules.

The notification is intended to achieve the above object.
