#### <u>ORDER</u>

The Principal Chief Conservator of Forests, (Forest Management) & Nodal Officer as per the letter read 1<sup>st</sup> above has recommended and forwarded the proposal for diversion of 0.1143 ha of forest land which is part of notified Kodassery Reserve Forest under Section 2 of Forest (Conservation) Act, 1980 for the purpose of providing drinking water facilities in Kodassery, Pariyaram and Athirappilly Panchayath of Chalakudy Taluk under KIIFB in favour of the Executive Engineer, Kerala Water Authority, Nattika.

2. Government as per the Order read 2nd paper above, have accorded inprinciple (Stage I) approval under Section 2 of Forest (Conservation) Act,1980 subject to the following conditions:-

1. Legal status of the forest land shall remain unchanged.

2. The User Agency shall give an undertaking to pay Net Present Value or any other Compensatory levies as per guidelines issued by Government of India.

3. The User Agency shall give an undertaking to pay additional Net Present Value if required.

4. The User Agency shall not fell any tree or cause damage to the surrounding of forest and shall take all possible measures to conserve tree growth.

5. The User Agency shall not use the forest land for any purpose other than the purpose for which the forest land is diverted.

6. When the forest land is no longer required for the purpose, the land will be resumed back to Forest Department.

7. The User Agency shall abide by any other condition imposed later on by

Government of India/Government of Kerala / Forest Department in the interest of Forest Conservation, to undertake that effect.

8. The User Agency shall apply for renewal after 20 years.

3. As per the letter read 3rd paper above, the Principal Chief Conservator of Forests, (Forest Management) & Nodal Officer has submitted compliance report informing that all the conditions stipulated while according Stage I clearance has been complied/agreed to comply by the User Agency.

4. In the circumstances, Government are pleased to accord Stage II/Final approval for diversion of 0.1143 ha of forest land which is part of notified Kodassery Reserve Forest under Section 2 of Forest (Conservation) Act, 1980 for the purpose of providing drinking water facilities in Kodassery, Pariyaram and Athirappilly Panchayath of Chalakudy Taluk under KIIFB in favour of the Executive Engineer, Kerala Water Authority, Nattika.
