**S. R. O. No. 764/2016.**—In exercise of the powers conferred by sub-sections (1) and (2) of section 28 of the Water (Prevention and Control of Pollution) Act, 1974 (Central Act 6 of 1974) read with rule 3 of the Water (Prevention and Control of Pollution) Appellate Authority Rules, 1977, and in supersession of the Notification Number I issued as G.O. (P) No. 09/2015/Envt., dated 29th June, 2015 and published as S.R.O. No. 417/2015 in the Kerala Gazette Extraordinary No. 1574 dated 29th June, 2015, the Government of Kerala hereby reconstitute the Appellate Authority for the disposal of appeals preferred against the

orders of the Kerala State Pollution Control Board for the prevention and control of water pollution under sections 25 to 27 of the Water (Prevention and Control of Pollution) Act, 1974 with the following members, namely:—

### **Explanatory Note**

(This does not form part of the notification, but it is intended to indicate its general purport.)

It has become necessary to reconstitute the Appellate Authority for the disposal of appeals preferred against the orders of the Kerala State Pollution Control Board under the Water (Prevention and Control of Pollution) Act, 1974 (Central Act 6 of 1974). Government have decided to reconstitute the Water Appellate Authority by nominating members by designation instead of nominating members by name so as to avoid frequent reconstitution of the Authority in charge of person so as to facilitate smooth functioning of the Authority.

The notification is intended to achieve the above object.
