As per Section 27 of the Mahatma Gandhi National Rural Employment Guarantee Act, 2005, Government of India have issued detailed instructions to the State Government to establish the Office of the Ombudsman for redressal of Grievances and disposal of complaints relating to implementation of the MGNREGS.

As per G.O.(Rt)No.185/2021/LSGD dated 22-01-2021 Government had re-constituted the Selection



Committee for preparing and recommending to Government, a ranked panel of persons found suitable for appointment as Ombudsman for MGNREGS in accordance with the instruction issued by Government of India.

The rank list prepared by the Selection Committee was notified vide Gazette Notification No.DD2-312/2019/LSGD dated 17.02.2021 (EOG No. 804 dated 18.02.2021) for public scrutiny. After considering the objections received within the prescribed time-limit, the Committee has recommended the rank list of persons for consideration for appointment as Ombudsman under MGNREGS in the State. Government have approved the following ranked list as per the recommendation of the Committee. This list is come into force with effect from the date of this notification and is valid for three years.

The appointment from this rank list will be subject to the final outcome of the W.A.No.2151/2019 filed by Sri. Sathianathan T.K. and another before the Hon'ble High Court of Kerala.
