ORDER

As per the Government Order read as 1st paper above a post of Deputy Director of Prosecution (Vigilance) was created in the scale of pay of ₹42,640 - ₹58,640 under the Vigilance & Anti-Corruption Bureau to represent Government in appeal cases before the Hon'ble High Court and in Special Judge's Courts and Vigilance Tribunals for conducting the prosecution of Vigilance Cases for the whole state and ordered that he shall be deemed to be public prosecutor as envisaged under section 5 (3) of Prevention of Corruption Act 1988. Subsequently, as per the Government Order read as 2nd paper above the post was redesignated as Additional Director of Prosecution (Vigilance).

- 2. Government had consequently decided to terminate the services of the present incumbent posted as Additional Director of Prosecution(Vigilance) and to call upon a panel of eligible persons from the Advocate General. Accordingly, the Advocate General vide letter read as 4th paper above had forwarded a panel of 3 advocates for being posted as Additional Director of Prosecution(Vigilance).
- 3. As per the Government Order read as 3rd paper above a Search Committee was constituted with the following members for making selection to the above post
 - i. Additional Chief Secretary (Home & Vigilance) - Chairman
 - ii. Secretary to Government, Law Department Member
 - iii. Director, Vigilance & Anti-Corruption Bureau - Member

4. The Search Committee which met on 05-08-16 scruitinised and verified the biodata of the candidates and recommended the name of Sri. K. D Babu, Flat No. 13 E, Rame Prakash Vihar, Lourdes Hospital Road, Near Railway Gate, Vaduthala, Kochi as the most suitable and competent person to be appointed as Additional Director of Prosecution(Vigilance)considering his 16 years of experience in Vigilance Services, 5 years Judicial Services and CBI experience.

5. In the above circumstances, Government are pleased to appoint Sri. K. D Babu, Flat No. 13 E, Ram Prakash Vihar, Lourdes Hospital Road, Near Railway Gate, Vaduthala, Kochi as Additional Director of Prosecution (Vigilance) in Vigilance & Anti-Corruption Bureau as per the recommendation of the Search Committee to represent Government in appeal cases before the Hon'ble High Court and in Special Judge's Courts and Vigilance Tribunals for conducting the prosecution of Vigilance Cases for the whole state.

NOTE FOR THE COUNCIL OF MINISTERS

This note relates to the appointment of Additional Director of Prosecution(Vigilance) in the Vigilance & Anti-Corruption Bureau.

- 2. As per G.O (Ms) 26/2011/Vig dated 13/09/2011, Government had created a post of Deputy Director of Prosecution (Vigilance) in the Vigilance & Anti-Corruption Bureau to represent Government in appeal cases before the Hon'ble High Court, in Special Judge's Courts and Vigilance Tribunals for conducting the prosecution of Vigilance Cases for the whole state and he shall be deemed to be public prosecutor as envisaged under section 5 (3) of Prevention of Corruption Act 1988. This post was later redesignated as Additional Director of Prosecution (Vigilance) as per G.O(Ms) No. 14/2013/Vig, dated 06/05/2013.
- 3. Now Government have decided to terminate the services of the present incumbent posted as Additional Director of Prosecution(Vigilance) and to call upon a panel of eligible persons from the Advocate General. Accordingly, Advocate General in his letter dated 13/07/2016 had forwarded a panel of 3 advocates for consideration for being posted as Additional Director of Prosecution(Vigilance).
- 4. As per G.O(Rt) No. 155/16/Vig, dated 15/07/16 a Search Committee has been constituted with the Additional Chief Secretary, (Home & Vigilance) as Chairman, the Secretary (Law Department) & the Director, Vigilance and Anti-Corruption Bureau as members for making selection to the post of Additional Director of Prosecution(Vigilance). The Search Committee met on 05/08/16 and after scruitinising and verifing the biodata of the candidates received from the Office of the Advocate General, the Committee unanimously decided to Sri. K. D Babu, Flat No. 13 E, Ram Prakash Vihar, recommend the name of Lourdes Hospital Road, Near Railway Gate Vaduthala, Kochi as the most suitable appointed as Additional Director competent person to be and

Prosecution(Vigilance)considering his 16 years experience in Vigilance Services, 5 years Judicial Services and CBI experience.

5. The Hon'ble Chief Minister has ordered to place the matter before the Council of Ministers.
