
Following clarifications are issued in regard to the distribution of fund allotted to CFLTCs:

- i. Break the Chain Campaign - Not payable by DDMA as the Covid19 Norms of Assistance from SDRF do not permit capacity building as in GO (Ms) No. 9/2020/DMD dated 17-3-2020
- ii. Sanitisers and Masks - Payable for the running of CCC/CFLTC/Institutional Quarantine Centres and for checking, screening and contact tracing
- iii. CCC/CFLTC/Institutional Quarantine Centres Management Expenses - Payable if the centres were used for quarantine purposes as per GO (Ms) No. 21/2020/DMD dated 25-6-2020
- iv. Community Kitchen - Payable only for migrant labourers but from PM Cares as per GO (Rt) No. 714/2020/DMD dated 14-9-2020
- v. Food and Medicine Delivery - Permissible for CCC/CFLTC/Institutional Quarantine Centres only
- vi. Sanitisation & Water Management - Permissible for CCC/CFLTC/Institutional Quarantine Centres only
- vii. Other Incidental Expenses - DDMA's may take a considered view on such expenses based on GO (Ms) No. 9/2020/DMD dated 17-3-2020 and GO (Ms) No. 21/2020/DMD dated 25-6-2020.

2) Following clarifications are issued for the District Disaster Management Authorities for settling the food bills related to running of CCC/CFLTC/Institutional Quarantine Centres, blockage of funds to be paid to Local Self Governments and for fixing rent as ordered vide GO read as 1st paper.

1. GO (Ms) No. 10/2020/DMD dated 19-3-2020 and GO (Ms) No. 11/2020/DMD dated 24-03-2020 are not applicable for settling the bills as per GO (Ms) No. 21/2020/DMD dated 25-6-2020. Hence, Rs. 60 and Rs. 45 per head ceiling is not applicable for settling the food bills related to running of CCC/CFLTC/Institutional Quarantine Centres.
2. Permitted to settle bills related to CCC/CFLTC/Institutional Quarantine Centres as approved vide GO (Ms) No. 9/2020/DMD dated 17-3-2020 or GO (Ms) No. 21/2020/DMD dated 25-6-2020 on a first come first serve basis from 2245-02-101-94-01 Flood Other Items, including food bills after due examination and satisfying itself that the expenditure is incurred only for the purpose of Covid19 containment.
3. Shall exercise Section 50 of the DM Act, 2005 and make itself satisfied as it deems appropriate under Section 66 that any particular expenditure claimed by Local Self Government is made for Covid19 containment and the payment claimed is genuine, before releasing funds from SDRF.
