ORDER

The Principal Chief Conservator of Forests (D & PFM) has reported that Government of India have sanctioned a project titled High Demanding Medicinal Tree Species of Kerala for an estimated cost of Rs.786.40 lakhs and have released Rs.314.56 lakhz as first instalment. As per NMPB guidelines the project fund can only be operated through a Nationalised Bank Account. Hence the Principal Chief Conservator of Forests (D & PFM) has sought Government sanction for opening new Account in a nationalised Bank in the name of Principal Chief Conservator of Forests (D & PFM), Kerala for depositing the fund released against the NMPB project and for the operating of the Account during the project period of 10 years from 2012-13.

Government have examined the matter and are pleased to accord Administrative Sanction for the project at an estimated cost of Rs.786-40 lakhs. Government have also accorded sanction for opening a separate Bank Account in SBT, Vazhutacaud, Thiruvananthapuram in the name of the Principal Chief Conservator of Forests (D & PFM), Kerala to operationalise the project sanctioned by Government of India for depositing the fund released against the NMPB project and for the operation of the Account during the project period of 10 years from 2012-13.
