R. O No. 1/83 in the Kerala Gazette Extraordinary No. 1 dated 1st January 1983, namely:—

AMENDMENT

In the said notification for the words "Kerala State Electricity Board", the words "Kerala State Electricity Board Limited" shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per the Notification No. 30429/ELA 2/82/PW&E dated 1st January, 1983, published as S. R. O No. 1/83 in the Kerala Gazette Extraordinary No. 1 dated 1st January, 1983, the Kerala State Electricity Board was included in the schedule to the Provident Fund Act, 1925 (Central Act 19 of 1925).

As per the Kerala Electricity Second Transfer Scheme (Re-vesting), 2013 issued by notification under G. O. (P) No. 46/2013/PD dated 31st October, 2013 and published as S. R. O. No. 871/2013 in the Kerala Gazette Extraordinary No. 3103 dated 31st October, 2013, Government have re-vested all the functions, properties and all interests, rights in properties, all rights and liabilities of the erstwhile Kerala State Electricity Board, taken over by the Government as per the Kerala Electricity First Transfer Scheme issued by Notification under G. O. (Ms.) No. 37/2008/PD dated 25th September, 2008, and published as S.R.O. No. 990/2008 in the Kerala Gazette Extraordinary No. 2090 dated 25th September, 2008, to the Kerala State Electricity Board Limited, a fully owned Government Company under the Companies Act, 1956 (Central Act 1 of 1956).

As per the Kerala Electricity Second Transfer (Amendment) Scheme (Re-vesting), 2014 issued by notification under G. O. (P) No. 11/2014/PD dated 11th April, 2014 and published as S. R. O No. 240/2014 in the Kerala Gazette Extraordinary No. 1043 dated 11th April, 2014, the Government have amended certain clauses of the Kerala Electricity Second Transfer Scheme (Re-vesting), 2013.

As provided under sub-clause (6) of clause 2 of the Kerala Electricity Second Transfer (Amendment) Scheme (Re-vesting), 2014 and in exercise of powers conferred by sub-section (3) of section 8 of the Provident Fund Act, 1925, the Government have decided to amend the said notification by substituting 'Kerala State Electricity Board Limited', for 'Kerala State Electricity Board' included in the Schedule to the Provident Fund Act, 1925 to enjoy the benefits under the Act.

The notification is intended to achieve the above object.
