**ORDER**

The Principal Chief Conservator of Forests (Forest, Land & Resources) & Nodal Officer FC Act & CAMPA as per the letter read 2nd paper above has recommended and forwarded a proposal for diversion of 0.2046 ha of forest land for concreting of Road in Kolayad Village in two different bits having width of 4 M. The Secretary, Kolayad Grama Panchayath is the user agency. The proposed road is a coupe road passing through Teak Plantations. The proposal doesn't involve any tree felling/clearing of forest.

2. Government have examined the proposal in detail based on the guidelines issued by the Government of India as per the letter read 1st paper above and are pleased to accord sanction for diversion of 0.2046 ha of forest land under Section 2 of Forest (Conservation) Act,1980 for concreting of Road in Kolayad Village in two different bits having width of 4 MMin favour of the Secretary, Kolayad Grama Panchayath subject to the following conditions:-


1. Legal status of the forest shall remain unchanged.
2. The User Agency shall pay Net Present Value as per guidelines issued by Government of India.
3. The User Agency shall make payment of Compensatory levies as directed by the authorities.
4. The User Agency shall not fell any trees or cause damage to the surrounding forest and shall take all possible measures to conserve the fauna and flora of the area.
5. The User Agency shall not use the forest land for any purpose other than the purpose for which the forest land is diverted.
6. When the forest land is no longer required for the purpose, the land will be resumed back to the Forest Department.
7. The User Agency shall abide by any other condition imposed later on by Government of Kerala/Forest Department/Government of India in the interest of Forest Conservation.
