- 6. The Chairman and Members of SEAC, Kerala shall hold office for a term of three years from the date of publication of this notification in the Official Gazette.
- 7. The SEAC, Kerala shall exercise such powers and follow such procedures as specified in the said notification.
- 8. The SEAC, Kerala shall function on the principle of collective responsibility and the Chairman shall endeavor to reach a consensus in each case, and if consensus cannot be reached, the view of the majority shall prevail.
- 9. The Government of Kerala shall notify an agency to act as Secretariat for the Authority, Kerala and SEAC, Kerala and the Secretariat shall provide all financial and logistic support including accommodation, transportation and such other facilities in respect of all their statutory functions.
- 10. The sitting fee, travelling allowances and dearness allowances to the Chairman and Members of the Authority, Kerala and SEAC, Kerala shall be paid as per the rules of the State Government of Kerala.
