NOTIFICATION

S. R. O. No. 780/2011.—WHEREAS, eleven members of the Tirurangadi Grama Panchayat have given notice of no-confidence motion against Smt. Poongadan Fathima, Vice President, Tirurangadi Grama Panchayat on 17th October, 2011;

AND WHEREAS, a meeting of the said Grama Panchayat was held on 2nd November, 2011, in the said Grama Panchayat Office under the Presidentship of the Secretary, Tirurangadi Block Panchayat to consider the said no-confidence motion;

AND WHEREAS, in the said meeting out of the sanctioned strength of twenty three members, thirteen members have voted in favour of the no-confidence motion and the Secretary, Tirurangadi Block Panchayat has declared the no-confidence motion against Smt. Poongadan Fathima as passed;

AND WHEREAS, after the passing of the said no-confidence motion the term of office of the Vice President of the said Grama Panchayat has come to an end and the Secretary, Tirurangadi Block Panchayat has reported the occurrence of the vacancy in the Office of the Vice President of the said Grama Panchayat to the Government and the State Election Commission;

AND WHEREAS, the said matter has been published in the notice board of the said Grama Panchayat;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (12) of section 157 of the Kerala Panchayat Raj Act, 1994 (13 of 1994), the Government of Kerala hereby notify that Smt. Poongadan Fathima has ceased to hold her office as Vice President of the Tirurangadi Grama Panchayat with effect from 2nd November, 2011.

Explanatory Note
