S. R. O. No. 774/2016.—In exercise of the powers conferred by sub-sections (1) and (2) of section 31 of the Air (Prevention and Control of Pollution) Act, 1981 (Central Act 14 of 1981) read with rule 3 of the Air (Prevention and Control of Pollution) Appellate Authority Rules, 1999, and in supersession of the Notification Number II issued as per G. O. (P) No. 9/2015/Envt. dated the 29th June, 2015 and published as S. R. O. No. 418/2015 in the Kerala Gazette Extraordinary No. 1574 dated 29th June, 2015, the Government of Kerala hereby reconstitute the Appellate Authority for the disposal of appeals preferred against the orders of the Kerala State Pollution Control Board for the prevention and control of air pollution under the Air (Prevention and Control of Pollution) Act, 1981 with the following members, namely:—

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

One of the members on the Air Appellate Authority constituted as per S. R. O. No. 418/2015 dated 29th June, 2015, i.e., Shri C. S. Yalaki, IFS has since been retired from the post of Director, Environment and Climate Change Department and hence the post of Administrative Member (Part-time) became vacant. Delay in reconstituting the Appellate Authority by inducting another officer in his place has caused difficulty to the litigants. In order to overcome such difficulties in future Government has decided to constitute Air Appellate Authority by appointing officers by designation only.

The notification is intended to achieve the above object.
