ORDER

Principal Chief Conservator of Forest (Social Forestry), Thiruvananthapuram as per letter read 1st above has reported that the Indian Institute of Space Science & Technology (IIST), Thiruvananthapuram has requested for the supply of 500 numbers of big bag seedlings(18x35 cm size) of indigenous tree species from Kerala Forest Department for afforestation of their campus annually for a period of three years from 2018 to 2020. The cost of raising seedlings will be borne entirely by IIST without causing any financial liability to Kerala Forest Department or Government. The total Cost of the project is Rs.67500./- (Rupees Sixty Seven thousand and Five Hundred only) for three years. The entire expense of raising seedlings shall be remitted by the IIST into the existing special TSB account in the name of Assistant Conservator of Forest (Social Forestry), Thiruvananthapuram. Hence PCCF(SF), Tvpm has requested Government to accord sanction for the proposal and also to grant permission to Assistant Conservator of Forests, Social Forestry Division, Thiruvananthapuram to receive money remitted by IIST authorities in the existing Special TSB Account No.799011400002730 of ACF(SF), Tvpm maintained in the District Treasury, Tvpm sanctioned as per G.O read 2nd above and to incur expenditure for raising the seedlings from the Special TSB Account.

Government have examined the proposal in detail and are pleased to accord sanction for the proposal for the supply of big bag seedlings from Social Forestry

Division, Thiruvananthapuram to Indian Institute of Space Science & Technology, (IIST)Thiruvananthapuram. Sanction is also accorded to the Assistant Conservator of Forests, Social Forestry Division, Thiruvananthapuram to receive the money remitted by the IIST authorities in the existing special TSB Account No..799011400002730 of the Assistant Conservator of Forests(Social Forestry), Thiruvananthapuram maintained in the District Treasury, Thiruvananthapuram sanctioned as per G.O read 2nd above and to incur expenditure for raising the seedlings from the Special TSB Account subject to the condition that the Principal Chief Conservator of Forest (Social Forestry) Thiruvananthapuram shall ensure that there is no liability for Kerala Forest Department or Government at any stage. He shall also make sure that the amount reported to be made available by Indian Institute of Space Science & Technology, Thiruvananthapuram is received in the concerned TSB account.
